II. Approval of Consent Agenda:

a. Tallahassee Update

Dr. Scoggin gave this update. GH is still working with Academia to create a GH brick and mortar in Florida. GH and Academica is trying to find a financial model that is feasible and still allows GH to provide a quality offering.
